Sub: - Disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015 - Purchase of Prime Land Parcel for Ultra-Luxury Residential Development in Bengaluru

In accordance with Regulation 30 of the SEBI (LODR) Regulations, 2015, we wish to inform that Umiya Buildtek, a subsidiary of Umiya Buildcon Limited, has successfully acquired a prime land parcel admeasuring approximately 20,000 sq. ft. in Bengaluru's Central Business District (CBD), off Cunningham Cross Road.

The purchase is intended for the development of a high-end, ultra-luxury boutique residential project. The plot offers a planned built-up potential of approximately 55,600 sq. ft., representing a significant addition to the premium real estate portfolio associated with Umiya Buildcon.

This project aligns with the Company's strategic focus on design-led developments catering to discerning homebuyers in supply-constrained but high-demand micro-markets such as Bengaluru's CBD.

Commenting on the development, Mr. Aniruddha Mehta, Chairman & Managing Director, stated: "This strengthens our presence in Bengaluru's ultra-prime residential segment. The Bengaluru CBD remains one of the most coveted locations, and this project underpins our commitment to delivering architecturally distinctive, future-ready homes that offer long-term value. We remain dedicated to disciplined execution and capital-efficient growth in premium real estate."

Upon completion, the project is expected to contribute an estimated ₹200 crore to the Company's balance sheet, supported by robust demand for luxury residences in the micro-market with **very limited new supply.** The development will also contribute to incremental economic activity and premium housing supply in the region.
